



## **Technip's proposed combination with FMC Technologies: filing by TechnipFMC of draft registration statement on Form S-4 with SEC**

August 11, 2016

Technip (Euronext Paris: TEC) announces today that a further step towards the proposed combination with FMC Technologies has been taken with the filing by TechnipFMC Limited ("TechnipFMC") of a draft of its registration statement on Form S-4 with the U.S. Securities and Exchange Commission (the "SEC").

As announced on May 19, 2016, Technip and FMC Technologies intend to combine their businesses in and under a new entity, TechnipFMC.

The Form S-4, the draft of which was filed with the SEC by TechnipFMC, will include the proxy statement of FMC Technologies for the vote of its stockholders on the proposed transaction and will also constitute a prospectus of TechnipFMC in the United States. In addition, Technip will prepare a separate information document to be made available to Technip shareholders in advance of the general meeting called to approve the proposed transaction. Before the completion of the transaction, TechnipFMC will also make publicly available a prospectus, prepared in accordance with the EU Prospectus Directive 2003/71/EC, with respect to the admission of its shares to trading on Euronext Paris.

The draft Form S-4 is available free of charge on the SEC website ([www.sec.gov](http://www.sec.gov)), on FMC Technologies' website ([www.fmctechnologies.com](http://www.fmctechnologies.com)) and on Technip's website ([www.technip.com](http://www.technip.com)).

TechnipFMC is providing in the draft of its Form S-4 certain information and in particular, detailed information on the proposed transaction, certain pro forma financial statements on a combined basis, descriptions of risks related to the transaction, terms of the business combination agreement and termination fees provided for in such agreement. The draft Form S-4 also includes information regarding Technip that has been provided to Technip's shareholders in Technip's Reference Document (*Document de Référence*) 2015 and the First Half 2016 Financial Report, as well as additional financial information, notably in the sections *Management's Discussion and Analysis of Financial Condition and Results of Operations of Technip* and *Technip Unaudited Financial Information*.

The transaction is expected to close in early 2017, subject to the approval of Technip and FMC Technologies shareholders, the conclusion of antitrust reviews in countries other than the United States, other regulatory approvals and consents, as well as other customary closing conditions.
